1. PURPOSES OF PROCESSING YOUR PERSONAL DATA

In this context, You accept and declare that you are aware that your personal information that you have submitted to our Company will be processed in order for you to benefit from products, advantages or campaigns, etc. in line with your needs, to provide general information and to provide all kinds of communication with you, and in this direction, your personal information will be used by our Company to send you information, promotional and marketing messages containing data, audio and video content to be transmitted directly or via SMS, pictures, animations, short messages, MMS containing multimedia objects, telephone, fax, automatic dialing machines, e-mail and similar communication channels, you have the right to refuse to send data, audio, video and all other kinds of messages at any time, completely or on a product and channel basis..

Cookies are small text files that are moved to your hard disk by the web server and then stored on your computer. Cookies help us better understand customer/user behavior during your visit to our website and use of our internet application; it provides information about usage and visit data. Accordingly, your personal or sensitive personal data is not stored in cookies and is not shared with other applications or persons. Finally, in order to fulfill our legal obligations, including our obligations under Labor Law No. 4857, Turkish Code of Obligations No. 6098, Social Security and General Health Insurance Law No. 5510 and Occupational Health Legislation, as well as our obligations under other relevant legislation for security measures, our branches are monitored by closed circuit video system for security reasons. The relevant records are kept within the legal periods in line with the purposes of the related services and, when necessary, are shared with the judicial authorities upon request due to the legal interest of our Company arising from the title of data controller and in cases stipulated by law.

4. DATA PROCESSING PERIOD AND RETENTION PERIOD

Your personal data, limited to the purposes specified in this Clarification Text; It will be processed by complying with the data processing and statute of limitations periods in all relevant laws and other legal legislation to which our Company and the centers and units affiliated to our Company are subject. In case of changes in the laws regarding data processing periods, the new periods determined will be taken as basis.

As a requirement of the principle of purpose limitation, your personal data is processed limited to the fulfillment of the purposes described in this Clarification Text and in any case limited to the period required to be processed in accordance with the legal periods, company practices and customs of commercial life, and after the expiration of the periods, it is deleted, destroyed or anonymized. If you want to get detailed information about the storage periods of your personal data, you can contact us via the addresses in the rights section of the relevant person.

5. RIGHTS OF THE DATA SUBJECT UNDER THE PDPL

Pursuant to Article 11 of the PDPL, you have the following rights regarding your personal data by applying to us;

- Find out if it is being processed,
- Request information if processed,

- Learn the purpose of processing and whether it is used for its intended purpose,
- Knowing the 3rd parties to whom it is transferred domestically / abroad,
- Request correction if incomplete / incorrectly processed, request deletion / destruction within the framework of the conditions stipulated in Article 7 of the KVKK,
- Request notification of the transactions made in accordance with the above-mentioned subparagraphs to the third parties to whom it is transferred,
- Object to the occurrence of a result to your detriment due to analysis exclusively by automated systems,
- Demand compensation for damages in case you suffer damage due to unlawful processing.

Your requests in your application will be finalized free of charge as soon as possible and within 30 days at the latest in accordance with Article 13 of the PDPL, depending on the nature of the request. However, if the transaction causes an additional cost for our Company, the fee in the tariff to be determined by the Personal Data Protection Board may be requested.
